Information about GB Non-native Species Risk Assessments

The Convention on Biological Diversity (CBD) emphasises the need for a precautionary approach towards non-native species where there is often a lack of firm scientific evidence. It also strongly promotes the use of good quality risk assessment to help underpin this approach. The GB risk analysis mechanism has been developed to help facilitate such an approach in Great Britain. It complies with the CBD and reflects standards used by other schemes such as the Intergovernmental Panel on Climate Change, European Plant Protection Organisation and European Food Safety Authority to ensure good practice.

Risk assessments, along with other information, are used to help support decision making in Great Britain. They do not in themselves determine government policy.

The Non-native Species Secretariat (NNSS) manages the risk analysis process on behalf of the GB Programme Board for Non-native Species. Risk assessments are carried out by independent experts from a range of organisations. As part of the risk analysis process risk assessments are:

- Completed using a consistent risk assessment template to ensure that the full range of issues recognised in international standards are addressed.
- Drafted by an independent expert on the species and peer reviewed by a different expert.
- Approved by an independent risk analysis panel (known as the Non-native Species Risk Analysis Panel or NNRAP) only when they are satisfied the assessment is fit-for-purpose.
- Approved for publication by the GB Programme Board for Non-native Species.
- Placed on the GB Non-native Species Secretariat (NNSS) website for a three month period of public comment.
- Finalised by the risk assessor to the satisfaction of the NNRAP.

Common misconceptions about risk assessments

To address a number of common misconceptions about non-native species risk assessments, the following points should be noted:

- Risk assessments consider only the risks posed by a species. They do not consider the practicalities, impacts or other issues relating to the management of the species. They therefore cannot on their own be used to determine what, if any, management response should be undertaken.
- Risk assessments are about negative impacts and are not meant to consider positive impacts that may also occur. The positive impacts would be considered as part of an overall policy decision.
- Risk assessments are advisory and therefore part of the suite of information on which policy decisions are based.
- Completed risk assessments are not final and absolute. Substantive new scientific evidence may prompt a re-evaluation of the risks and/or a change of policy.

Period for comment

Draft risk assessments are available for a period of three months from the date of posting on the NNSS website*. During this time stakeholders are invited to comment on the scientific evidence which underpins the assessments or provide information on other relevant evidence or research that may be available. Relevant comments are collated by the NNSS and sent to the risk assessor. The assessor reviews the comments and, if necessary, amends the risk assessment. The final risk assessment is then checked and approved by the NNRAP.

E. nitens can hybridise when in proximity to other species e.g. with E. dalympleana, E. globulus and E. crenulata, though this would not normally occur in its native range (Trabado 2008). Natural hybrids in its natural range have been suggested between E. nitens and E. denticulata (CABI 2005). Reputed natural hybrids have been observed between E. nitens, E. badjensis and E. cypellocarpa (Griffin et al 1988), E glaucescens (Tibbits, 2000), and E. viminalis (CABI 2005). Hybrids can ormally be distinguished by morphological measurements. Africa) (FAO 2008, Yoshioka 2009). The greatest area of concern appears to be Australia where <i>E.nitens</i> has been planted outside its natural range and has the potential to hybridise with other rarer species of eucalypt (Barbour 200 There is no evidence of pure <i>E.nitens</i> negenerating naturally in GB, though artificial hybrids involving <i>E.niten</i> may have shown this ability (Macpherson pers com).

YES or UNCERTAIN (Go to 9)	Seed is fairly small (~400+ per gram, Forestart 2009, Royston Petrie Seeds 2011; 270 viable seeds + chaff per gram, Turnbull & Doran 1987) and can be numerous (CABI 2005), and presumably liable to some wind dispersal. It can show rapid growth but is less able to tolerate coppicing than other eucalypts (CABI 2005). It only rarely able to reproduce vegetatively by means of lignotubers and epicormic buds (Trabado 2007). The is no indication that it would not be susceptible to standard herbicides if control was needed. In GB, dispersa: appears to have been intentional and there is no indication that natural regeneration occurs. There is unconfirmed evidence of complex hybrids of <i>E nitens</i> being capable of natural regeneration in the wild. (Macpherson pers com 2009). However, there is no confirmed evidence of self-seeding by pure <i>E. nitens</i> , though theoretically this could occur. Orwa et al (2009) suggests that regeneration of <i>E nitens</i> from seed can be prolific on ash beds following burning, but do not indicate whether this has been observed only within its original range, or elsewhere.

Seed is normally sold in small quantities to be grown under managed conditions in commercial or private nursery areas, usually indoors. Seed germination is erratic (Jungleseeds 2009) and particular conditions suitable for germination are needed (full sunlight, moisture, bare soil, protection from predators and possibly a period of cold stratification) (Krugman & Whitesell 1974, John Purse 2009). Seedlings are delicate and do not tolerate droughting, frosts or competition with other vegetation (Krugman & Whitesell 1974, Bell & Williams 1997, Meskimen & Francis 1990). Mature trees can produce viable seed quite early (from 4-5 years, Potts et al 2001, Celyn Vale 2011) and can produce large quantities of seed, but dispersal away from the parent is likely to be slow (Cremer 1977).

(Randy Stewart Landscape designs 2011). The majority of GB apart from the high Pennines and Scottish uplands comes into the USDA plant hardiness categories 8a to 10a (e.g. Trebrown Nursery 31/03/2011), and provides the broad annual rainfall requirements and similar climatic conditions to those required for establishment. E nitens occurs naturally in the mountains of south-easter Australia at between 600-1600 masl. In these areas, the climate is cool to warm, humid to subhumid, (500-2160mm precipitation, with a dry season of between 0-3 months duration) with mild summers rarely having very high temperatures (max temp of hottest month 19-29°C and the mean minimum of the coldest month about -3°C to 7°C). Winter frosts are numerous and severe, with 50-150 days annually and an absolute minimum of -12°C. Snow occurs over most of the distribution and may remain on the growing commercial Eucalyptus species and is moderately drought resistant. (Orwa et al 2009, CABI 2005). Established trees are hardy to approximately -12°C. (John Purse 2009). The current worldwide distribution of E nitens includes: SE Australia & Tasmania, New Zealand, South Africa, USA, Russian Federation, China, India, Iran, Zimbabwe, Argentina, Chile and Colombia. It is also increasingly grown in several countries in western Europe including France, Italy, Spain, Portugal Great Britain and Ireland. Optimum temperature for germination for two varieties of E nitens was between 18°C and 28°C (Humara, J.M. et al, 2000). Krugman & Whitesell (1974) state that a pre-germination cold stratification is required. Growers recommend that seeds are germinated early in the year so that seedlings are well-grown enough to deal with the following winters cold conditions. This might mean that warmer areas with a longer growing season (i.e. the south and west of GB) may favour establishment from se
	How similar are other abiotic factors that would affect establishment in the Risk Assessment area and in the area of present distribution?	similar - 3	LOW - 0	E. nitens prefers deep, moist loams, but it will grow satisfactorily on a wide range of moderately fertile soils, especially if there is clay in the subsoil. The sites are usually well drained and their pH values fall within the range of 4.5 to 6.0. (Turnbull and Pryor, 1984). Such soil conditions are fairly widely distributed in GB. However, natural regeneration may depend on the availability of freshly burnt areas (CABI 2005), cleared of vegetation, which are relatively uncommon.

Specify the species or habitats and indicate the number.	moderate number - 2	MEDIUM -1	In its natural habitat, E. nitens occurs in the hills and valleys in mountain areas (Orwa et al 2009). In GB it is likely that the majority of habitats that might support the growth of woodland or scrub could be suitable. However, due to the small size of the seed, the seedlings have very small reserves and so are unable to tolerate shade or weedy competition. In order to germinate and establish, Eucalyptus seed need contact with bare mineral soil and sunlight to develop, and the seedlings are delicate and cannot suffer competition with other plants (Krugman & Whitesell 1974, Bell & Williams 1997, Meskimen & Francis 1990). Hence, areas of bare soil where weeds are suppressed (e.g land prepared for agricultural crops, or burnt areas) that are immediately adjacent to large numbers of parent trees could provide the most optimal conditions. However, the specific conditions necessary for survival and development within these habitat types (i.e. bare ground with little competition from other vegetation) may be relatively uncommon.

Like other Eucalypts, mature E nitens may be vulnerable to psyllids, aphids, beetles and mildews but damage is likely to be merely cosmetic. It is vulnerable to chrysomelid beetles, leaf fungi and powdery mildews (CABI 2005). E nitens is considered relatively unpalatable to browsing animals. (Orwa et al 2009, John Purse 2009)

In all these situations trees are initially grown from seed in carefully managed conditions (greenhouse or nursery) before being transplanted as a seedling in prepared ground, and with little or no competition with other plants. Herbicides may be used to control weeds around seedlings / saplings in such plantations so there may be potential for unintended growth of E nitens on these sites. Artificial burning or weed control in sites adjacent to mature E nitens could aid establishment.

It can produce fine seed from age 3 years onwards (Potts et al 2001) but may not flower heavily and produce large quantities of seed until 7-10 years (Eldridge et al 1993). This species has a reputation for small seed crops and slow flowering (CABI 2005). Seed can potentially remain viable for several years, although it is palatable to small animals (John Purse pers com).

There appears to be no evidence of natural regeneration in other countries outside Australia. The current worldwide distribution of E nitens through cultivation includes: Tasmania, New Zealand, South Africa, USA, Russian Federation, China, India, Iran, Zimbabwe, Argentina, Chile and Colombia. It is also increasingly grown in several countries in western Europe including France, Italy, Spain, Portugal Great Britain and Ireland (Barclay 2004, Krugman & Whitesell 1974, Orwa et al 2009, FCS 2009).

At least 12 trial sites researching the usefulness of this species in short rotation forestry have recently been set up in Scotland by Forest Commission Scotland & in England for the Department of Energy & Climate Change (DECC) (FCS 2010). If these trials prove successful it is likely that larger scale deliberate planting and possibly more experimental trials will follow, thereby maintaining populations in GB. As hardier varieties are established sales of seed and small saplings may also increase for use as ornamental garden plants.

Generally, seed dispersal is limited in the Eucalyptus genus (Potts & Reid 1988), the key agent being wind (Turnbull & Doran 1987). E nitens seeds are small (170-400 per gram germinable Forestart 2008; 270 per g Turnbull & Doran 1987) and unwinged. The seeds would be expected to fall close (less than twice the tree height) to the parent i.e. within <80m (Cremer 1977). Greater drift of seeds might be possible in storm conditions. It is possible that seed could be transported to fall close (less than twice the tree height) to the parent i.e. within <80m (Cremer 1977). Greater drift of seeds might be possible in storm conditions. It is possible that seed could be transported by water either by falling into streams, or in surface water especially in storm events. Dispersal by birds or animals is unlikely: whilst the capsules of some species of Eucalypt have been observed to be eaten by birds, (probably parrots), it is not common and seed is unlikely to survive passage through the gut. (O'Sullivan 2011). The capsules and seed are smooth and are unlikely to be transported accidentally by animals by adhering to hair or skin. This species is considered fairly unpalatable and saplings only occasionally browsed heavily by deer and rabbits (Purse, J), though there is no specific information available on the palatibility of the seeds or capsules to animals in GB. The seed is fine and unlikely to be cached underground by rodents. Under natural conditions Eucalyptus seed viability falls rapidly after about 2 months and is very low after 12 months (Carey 2002), so even if seed were transported, high volumes are unlikely to build up.

Hence, areas of bare soil where weeds are suppressed (e.g prepared areas for forestry and agricultural crops, or recently burnt areas) that are immediately adjacent to large numbers of parent trees could provide the most optimal conditions. Ideal germination conditions may suggest that warmer areas with a longer growing season in the south and west could favour establishment from seed.

It is possible that warmer sites in the south of GB may favour survival of seedlings, and could suffer through increased fire risk and lowering of local water tables. The most vulnerable sites might be arable, or recently burned areas, immediately adjacent to plantations of E nitens.

It can produce viable seed but there is little evidence for significant natural regeneration or rapid spread from areas where it is being grown. However, there is interest in identifying more frost-tolerant varieties and hybrids of E nitens crossed with other Eucalypt species. The potential for invasiveness of these is not yet known and will need to be monitored.
